PAYMENT OPTIONS:

- **Girls who are signed up for weekly payments:** your payments are due every Monday.
- **Girls who are signed up as day rate:** you can pay each day your child attends or in advance for the week.

*** Your account must be paid on time or placement could be jeopardized. ***

We accept checks, credit cards, exact cash, and you can use online bill pay with your bank to submit payments.

Tuition is based upon the agreement you completed at sign up. You have agreed to pay the total tuition designated in the contract. Discounts will not be applied for missing part of the contracted month. **No refunds.**

MEDICINE

It is important to let us know what is going on with your child. If she needs an EpiPen, Inhaler, or other medication while at Girls Inc., please bring to leave at the center. All medications must be in a prescription bottle with the RX tag that has the correct information.

SUNSCREEN

You must provide sunscreen for your child. The girls will apply their own sunscreen before they go outside as needed. They will then re-apply at the afternoon snack break. *Staff will be available to assist girls apply sunscreen if needed.*

ELECTRONICS AND PERSONAL BELONGINGS FROM HOME

We strongly **discourage** your child bringing cell phones, electronics, or items from home to the center. We recommend your child bring a change of clothes in the case of an emergency. If they do not want to eat the lunch provided, please send a sack lunch. Items cannot be refrigerated or microwaved. They may bring a backpack to keep these items in. *Girls Inc. is not responsible for lost, stolen, or damaged items.*

Field Trips

- **All field trips will be on Fridays**, with the exception of Sisterhood only visits, which take place on Mondays.
- **EVERY GIRL MUST WEAR THEIR GIRLS INC. T-SHIRT** and tennis shoes/shoes with a back strap.
- If your child is not here by the field trip departure time, they will not be allowed to stay. **No exceptions.**
- A final roll call will be conducted at Girls Inc. upon our arrival from the field trips. Please be patient in waiting to sign your child out AFTER roll call.
- If the trip is not within walking distance, Franklin Community Schools will transport us via bus.
- There are NO additional costs for field trips. Please do not send money for souvenirs, snacks, etc.
- Everyone who is in attendance that day will attend the field trip & the center will be closed.



SWIMMING

- Please send your child in their swimsuit under their clothes on their swim day. We do not have enough bathroom space and time for each girl to change into their swimsuits.

- Please send sunscreen, a towel, a bag to carry their belongings with your child.
- Girls may bring goggles, nose plugs, or their own Coast Guard approved life vest. They will not be allowed to bring any other kind of pool toy or raft. Girls will be responsible for their items and have to carry them to and from the pool.
- Girls Inc. will provide a snack upon returning to the center around 4:00 pm. If you would like to send money for your child to utilize the snack bar, you may do so at your own discretion. Girls will be responsible for their own money.
- Girls must wear tennis shoes on their pool day to walk to and from the pool. They may bring flip flops to wear on the pool deck.

- Shoes must have a back. Your child will not be allowed to stay if she is wearing flip flops.
- Girls Inc. t-shirt must remain as you received it. No cutting, beading, painting, etc.
